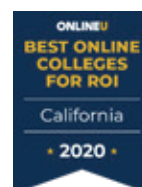

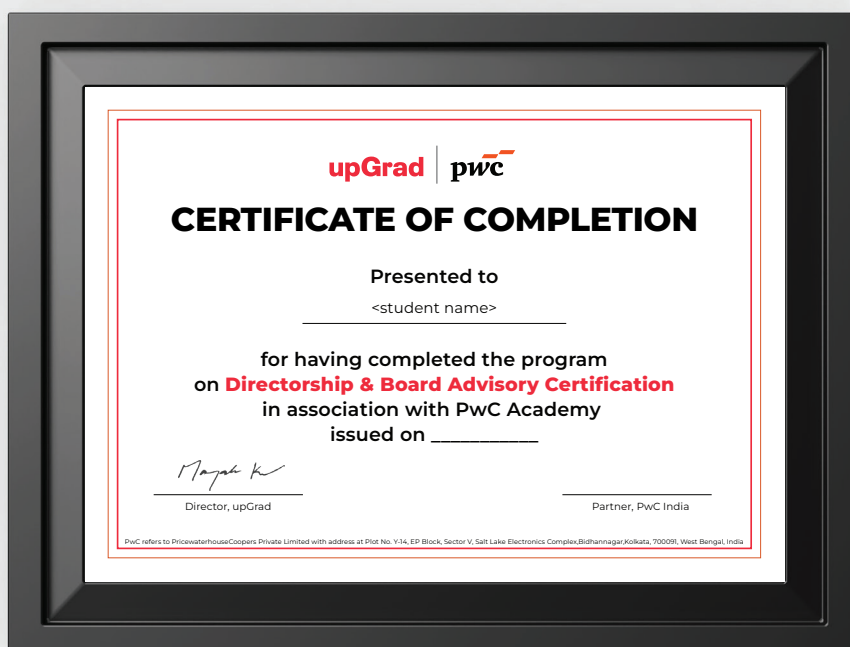

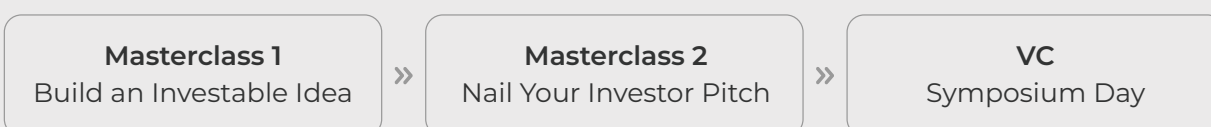

The **Doctor of Business Administration (DBA)** program is designed for professionals who want to further their career with the most advanced business degree program GGU offers. 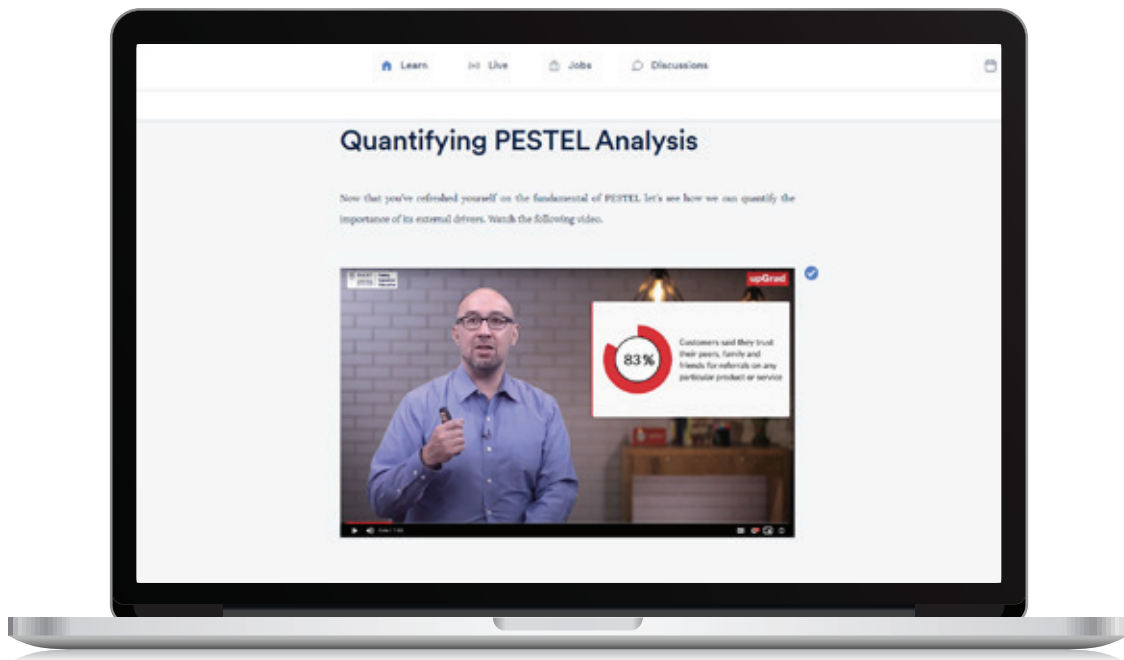

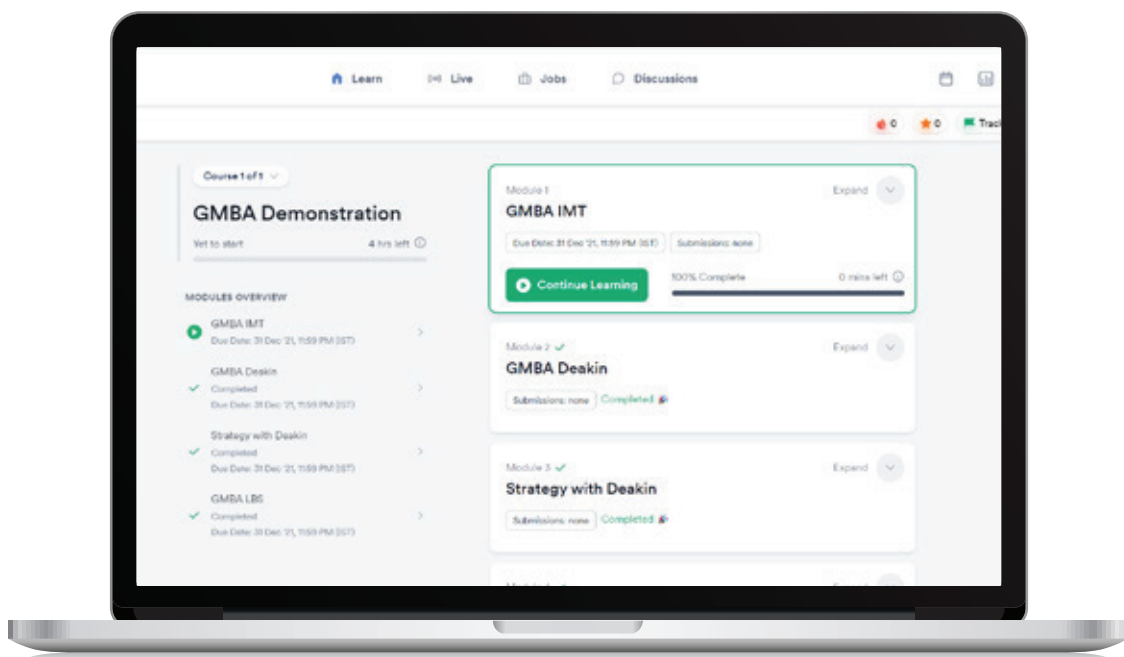
