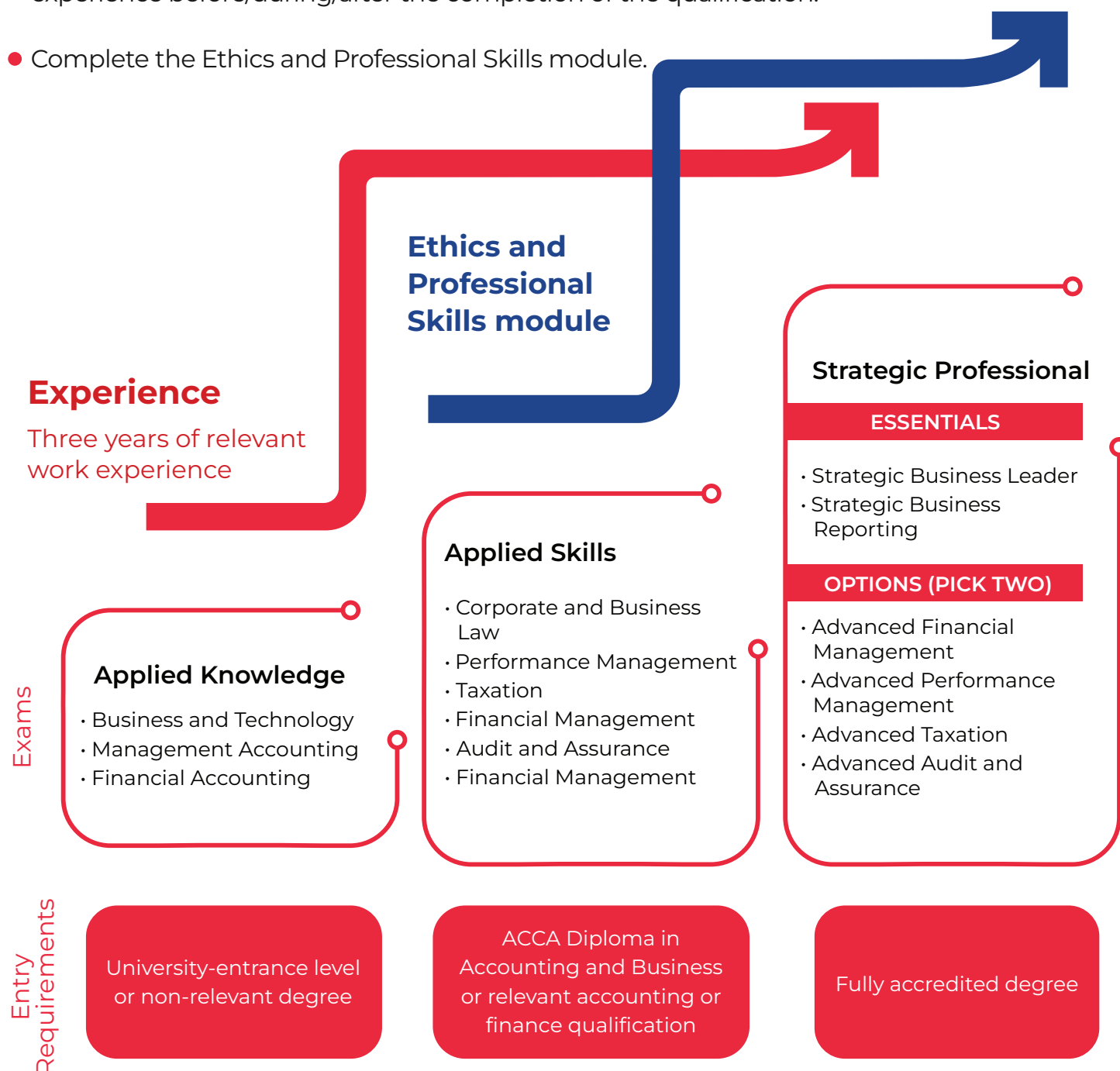

- Record 3 years' work experience in a relevant role. The candidate can acquire the experience before/during/after the completion of the qualification.
- Complete the Ethics and Professional Skills module.
